a. The purpose of this modification is to change the following:

(1) Page 1, Paragraph 5.a(1), change the Program Management Office symbol from HQ AMC/DONT to HQ AMC/LGTT.

(2) Page 1, Paragraph 5.a(1), change the Administrative Contracting Office symbol from HQ AMC/DOYM to HQ AMC/DOYMB.

(3) Page 22, Paragraph 4.4.3, Contingency/Redirection/Surges, change to read "In the event of a contingency/state of war (declared or not), emergency or other situation where transportation disruptions are affecting DOD-wide express shipment delivery, the contractor (carrier) shall contact the Program Office for advisory notice guidance regarding shipment disposition implications to the contractor (carrier) and Service/Agency representatives (i.e. Agency Contracting Officer's Representative (ACOR)). However, when shipments are undeliverable for localized situations, the contractor (carrier) will contact the applicable shipper(s) for disposition instructions regarding any change in shipment status (e.g., delayed delivery, undeliverable shipments, misdirected shipments). If this shipment redirection causes a rate increase or decrease in the cost of performance, the contractor shall notify the origin shipper, in writing, as soon as practicable."

b. There is no cost associated with these changes. There are no other changes to the Blanket Purchase Agreement as a result of this modification.
